

WAIVER AND RELEASE FROM LIABILITY AND HOLD HARMLESS AGREEMENT PATRIOTS OF CHARLESTON/THE CHARLESTON TEA PARTY ORGANIZATION or ASSIGNS

In consideration for taking part in the "Day Trip" or "Extended Stay" bus trip to the Glenn Beck Restoring Honor Rally, I, _____ HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge **Patriots of Charleston/The Charleston Tea Party Organization** and its agents, employees, officers, directors, affiliates, successors, volunteers and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I ever had or may have, or any loss, damage or injury, that may be sustained by me, or any loss or damage to property owned by me, whether caused by the negligence of any volunteer, or otherwise in any way related to my participation in this trip.

I understand the risks and hazards associated with participating in a bus ride and a rally and I am fully aware that there may be risks and hazards unknown to me. I hereby elect to voluntarily participate in the trip and assume all the risk. I also voluntarily assume full responsibility for any risk of loss, property damage, or personal injury that might be sustained by me, or any loss or damage to property owned by me as a result of my being a participant in this trip, whether caused by the negligence of volunteers or others. On behalf of myself, my heirs, assigns and next of kin, I waive all claims for damages, injuries and death sustained to me or my property, that I may have against the aforementioned released party to such activity.

The "Day Trip" bus will depart from the south side of Constitution Avenue at 17th Street on August 28th at 6:00 PM. If I am late, I understand that I am responsible for finding my own transportation back to Charleston and I will not hold the volunteers or **Patriots of Charleston/The Charleston Tea Party Organization** responsible for any of the cost related to such transportation.

The "Extended Stay" bus will depart the Holiday Inn Rosslyn at Key Bridge on August 29th at 12 NOON. If I am late, I understand that I am responsible for finding my own transportation back to Charleston and I will not hold the volunteers or **Patriots of Charleston/The Charleston Tea Party Organization** responsible for any of the cost related to such transportation.

I have read, understand and fully agree to the terms of this WAIVER AND RELEASE. I understand and confirm that by signing this WAIVER AND RELEASE I have given up considerable future legal rights. I have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law. I am 18 year of age or older and mentally competent to enter into this waiver on behalf of myself or on behalf of my minor child.
